#### **RIGHT TO RESCHEDULE**

Should world conditions affect the staging of the tour (e.g., natural disasters, including, but

not limited to, pandemics; war; terrorism), Transcendent Travel reserves the right to schedule the tour to a later date. In the event a tour participant is not willing to reschedule, and it is within 90 days of the tour start date, all deposits and/or tour payments will be returned to such tour participant who has signed up, less any non-refundable expenses actually incurred by Transcendent.

### Health and Safety

The health and safety of our customers is always our top priority. Each tour will have COVID-19 guidelines in place based on local requirements. As local ordinances may be updated regularly, we will share any changes to our policies closer to the tour start date. We reserve the right to update these on an ongoing basis per the available data and recommendations of local authorities. If borders are closed or we have any doubts about the health and safety of a destination and cannot operate a tour, we will give you first notice on a later set of dates. Any refunds will be determined in accordance with our Worry-Free Travel and Right-To-Reschedule Policies noted above.

#### Tour Guide

Should the original tour director be unable to lead the tour on behalf of Transcendent Travel, Transcendent reserves the right to engage another competent tour director to lead and execute the tour.

#### SUBSTITUTIONS

Transcendent recognizes that circumstances occur where it may be necessary to cancel participation in the tour. Substitutions are encouraged so that cancellation fees can be avoided. For substitutions made within 30 days of a tour date, an additional substitution fee of \$500 USD will apply.

#### INSURANCE
